AN ORDINANCE OF THE CITY OF TAMPA, FLORIDA, APPROVING A COMMUNITY DEVELOPMENT DISTRICT FOR CORY LAKES LIMITED, PURSUANT TO CHAPTER 190, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Chapter 190.005(2) requires that Community Development Districts of less than 1000 acres in size be established by the local government; and

WHEREAS, Cory Lakes Limited has filed a petition containing all documentation required by Chapter 190, Florida Statutes, and

WHEREAS, the City has reviewed said petition and determined that it meets all applicable criteria, as specified in Chapter 190.005(1)(e), Florida Statutes.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA:

- That the City of Tampa hereby approves the Section 1. establishment of the Community Development District at Cory Lakes pursuant to Chapter 190, Florida Statutes.
- Section 2. That the land to be served by the Community Development District comprises approximately 600 acres. It is located in the City of Tampa on State Road 582 A, approximately five (5) miles northeast of the I-75/Fletcher Avenue interchange, more fully described in Exhibit "A".
- Section 3. That the initial members of the Cory Lakes Community Development District are Dayne Piercefield, Bob Humphries, Hugh McArthur, Eugene Thomason, and Irving (Al) Beauchamp.
- Section 4. That the District will officially be named the Cory Lakes Community Development District.
- Section 5. That if any part of this Ordinance shall be declared unconstitutional or invalid by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.
- Section 6. That all Ordinances in conflict herewith are repealed to the extent of any conflict.

Section 7. That this Ordinance shall take effect immediately upon becoming a law.
